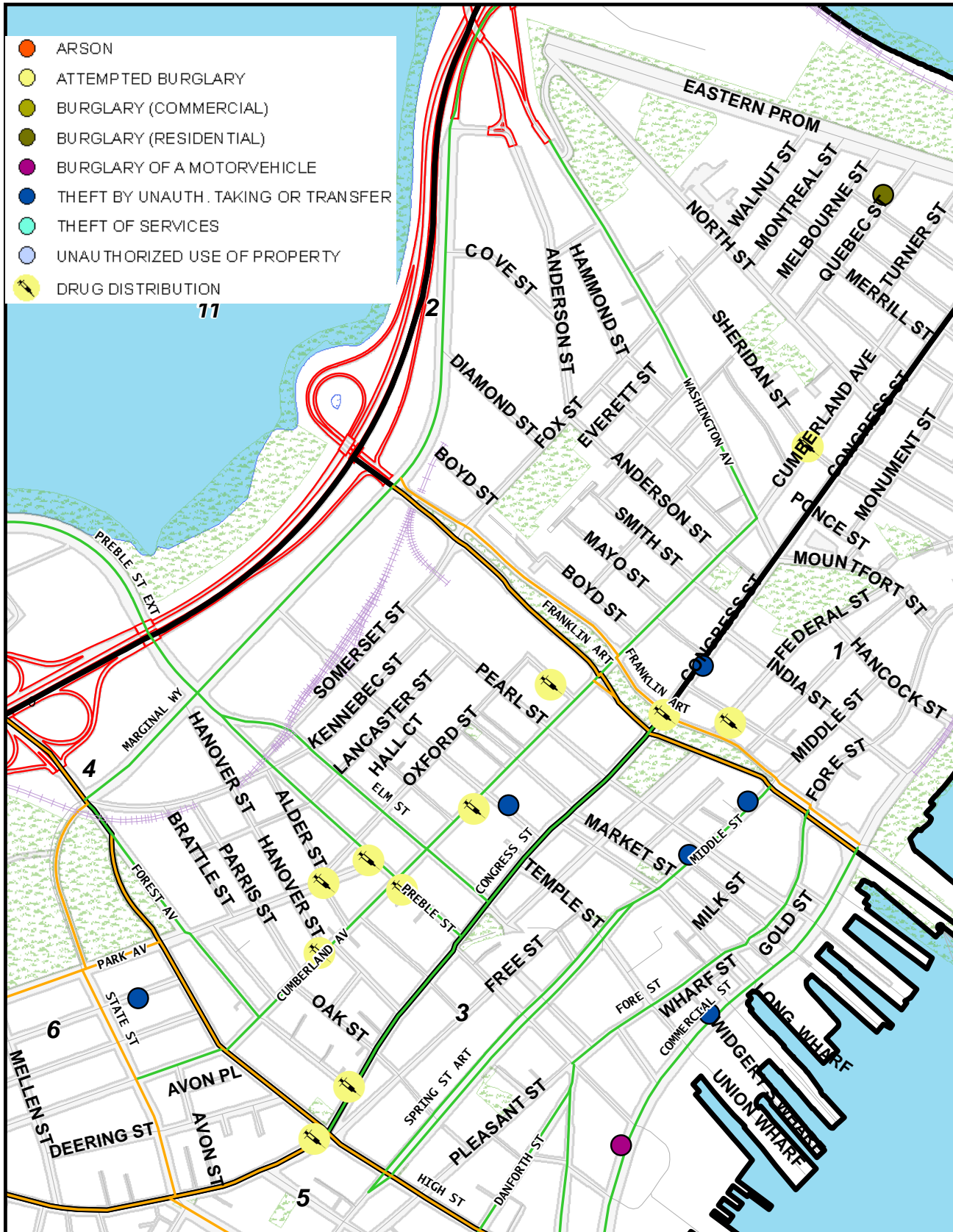

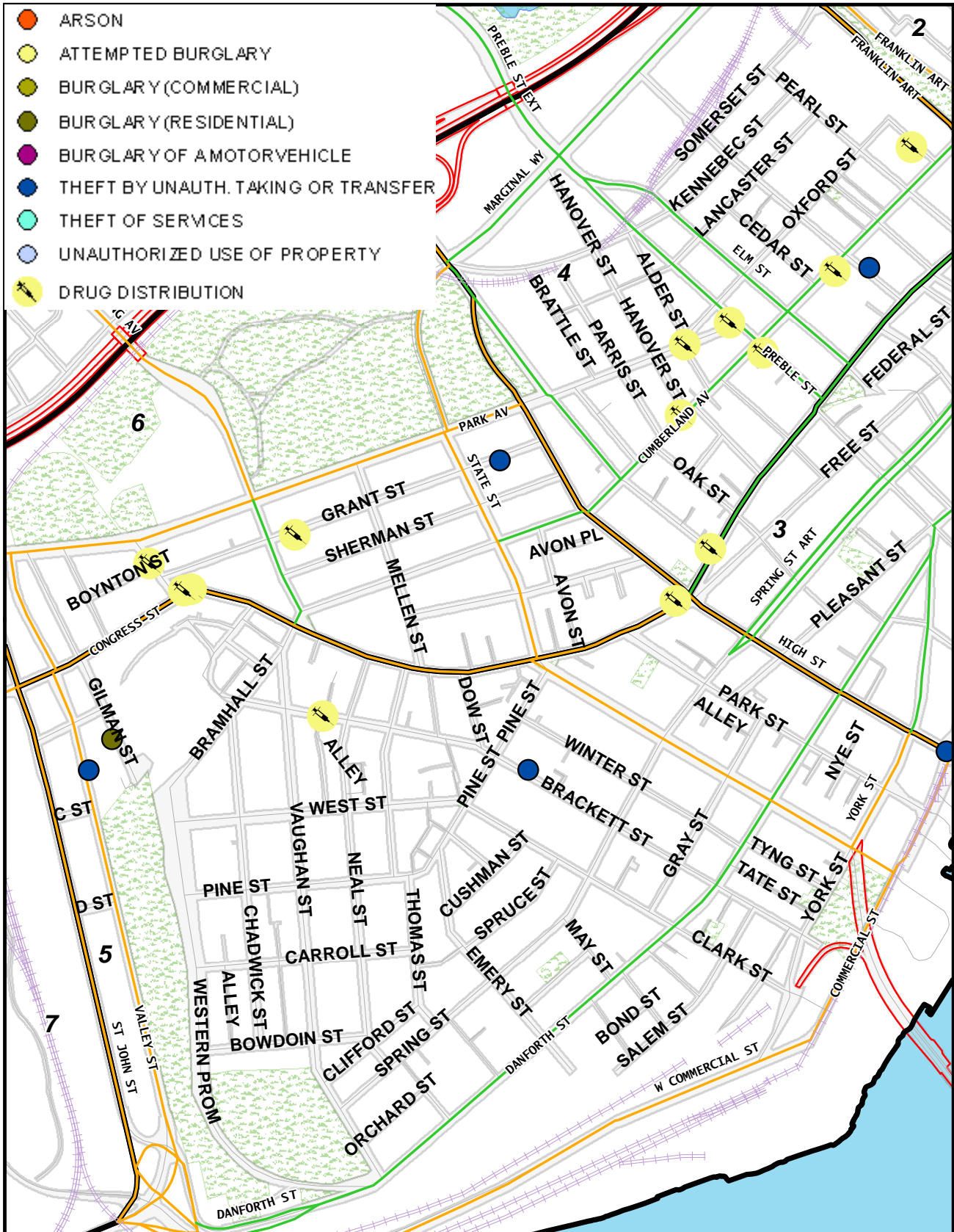

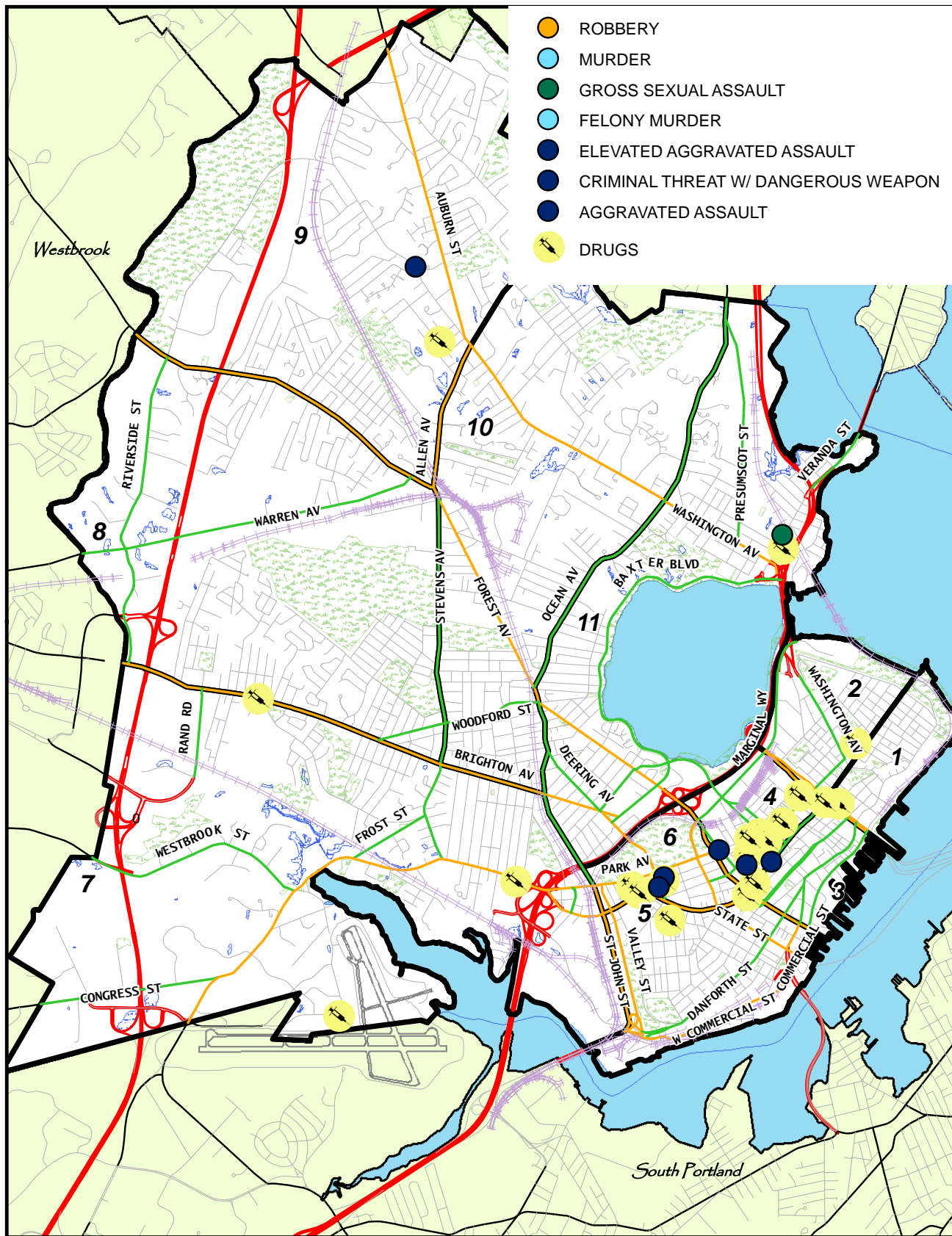
Property Crime Beat 3 and 4

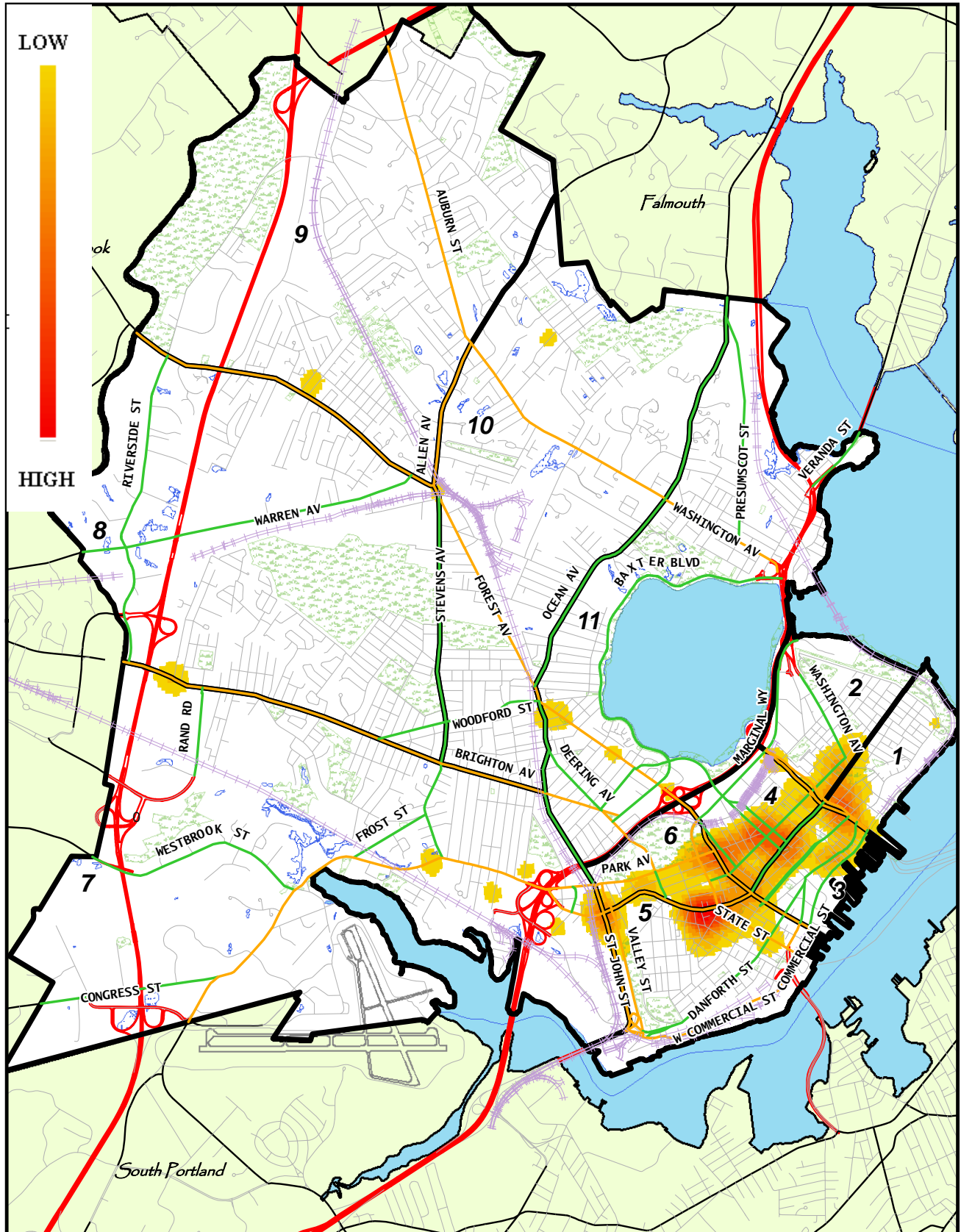

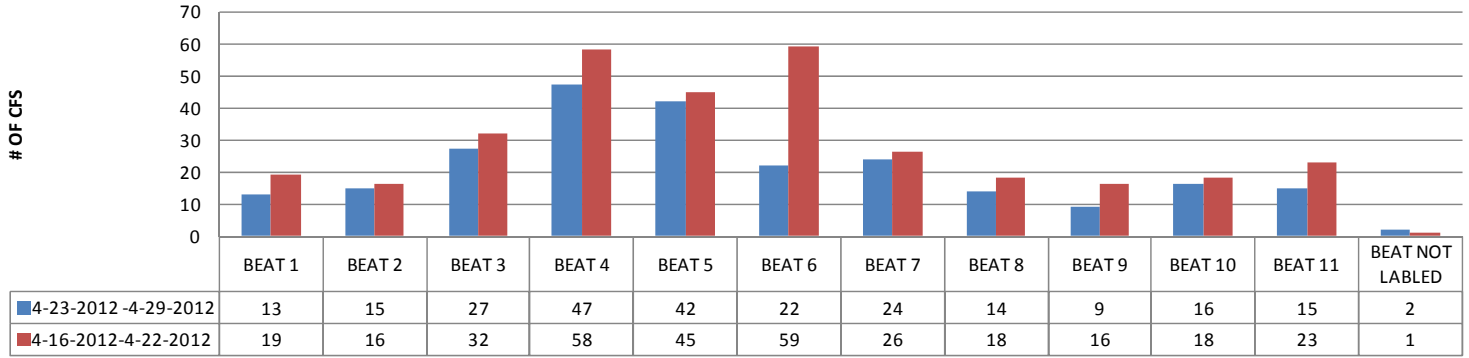
